Preamble

The PARTNER is a trading company specialized in firefighting equipment.
POK SAS is a manufacturer specialized in manufacturing firefighting equipment and owner of the trademark POK.

1. Trading agreement

- 1.1 The PARTNER has the right to sell POK SAS products.
- 1.2 This trading agreement is valid for all customers from the following country: The Republic of Trinidad and Tobago.

3. Duration of the contract

The contract starts on the 23.04.2020 for an indefinite period and can be terminated by either party, with a notice period of three months.

4. Miscellaneous

This contract shall be governed by the laws of France. The exclusive place of jurisdiction for all disputes arising from and in connection with this contract is the registered office of POK SAS. Amendments and supplements to this contract must be made in writing to be effective and approved by both parties. This also applies to the cancellation of the written form requirement. The parties have not entered into any oral collateral covenants.

If any individual term of the contract should be invalid or if it should contain omissions, the validity of the other terms shall not be affected. In place of an invalid provision, a valid provision that corresponds to the meaning and purpose of the inoperative provision shall be agreed upon. In case of an omission, the valid provision shall be agreed upon that corresponds to what would have been agreed upon, if the matter had been considered from the outset, bearing in mind the meaning and purpose of this contract.

All previous contracts - whether known or unknown - hereby lose their validity.

Neither party shall assign and/or transfer this contract in whole or in part to any individual, firm or corporation without the prior written consent of the other party.

Both the PARTNER and POK SAS shall keep in strict confidence from any third party(s) and all-important matters as to the business affairs and transactions covered by the agreement.
